BOAT LIFT/PIER SECTION
Release and Waiver for Liability and Indemnity Agreement

BOAT LIFT/ PIER STORAGE: Release and Waiver for Liability and Indemnity Agreement The undersigned acknowledges that the Summer Village of Val Quentin is extending a special privilege in allowing Val Quentin Residents to store his or her boat lift or pier sections **during the dates provided below**. In consideration of the privilege to store boat lifts and pier sections at the designated Summer Village Park, identified below the undersigned, for himself or herself and any personal representative, heirs, and next of kin, hereby acknowledges, agrees and represents the following:

RELEASE: I agree to release, waive, discharge, and covenant not to sue the Summer Village of Val Quentin, its Councillors, officers, employees, and agents from all liability to me, my personal representative, heirs, and next of kin for any loss, injury, theft, damage, claim or demands therefore on account of injury to my property, whether caused by the negligence of the Village or otherwise during the dates provided below.

INDEMNIFICATION: I agree to indemnify and save and hold harmless the Summer Village of Val Quentin from any loss, liability, theft, injury, damage or cost that may incur due to my storing my boat lift or pier sections, upon or about the Summer Village of Val Quentin premises whether caused by the negligence of the Village or otherwise.

ACCEPTANCE OF RISK: I understand that the Village never intended, nor designed the park noted below to be used as a storage facility and I acknowledge that the Village does not guarantee the security of the property being stored. In addition, I realize that the park is not locked, secured or guarded. Therefore, I agree to assume full responsibility for and risk of property damage due to the negligence of the Village or otherwise while my property is stored during the dates provided below.

POLICY: I agree to abide with the Public Safety policies, available on request, which state that any stored device in violation of Village policies is subject to fine and/or removal according to the Village Policies. In addition, I acknowledge that the permit to store my boat lift or pier sections in the above-mentioned park is valid only during the time period of **September 1st to May 31st**. I also agree to pay for all costs incurred by the Village associated with the removal of said boat lift or pier sections.

CONTACT PERSON: I agree to provide a contact person and a phone number in my absence so that, in the event of an emergency, the contact person will be responsible for my stored equipment. The undersigned further expressly agree that the foregoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as Alberta law allows and that, if any portion is held invalid, it is agreed that the balance shall continue in full legal force and effect.
